

## Solid Waste Hauler's Permit Application

Application for a permit to engage in the business of Collection and/or Transportation of Solid Waste in the Ozark Mountain Solid Waste District, anywhere in the counties of Baxter, Boone, Carroll, Marion, Newton and /or Searcy.

Notice: It is a violation of Arkansas Law to engage in the business of collecting or hauling solid waste anywhere in the state without a valid permit issued by the Solid Waste Management District in which that business operates. Any company or person must have a valid Hauler's Permit if all or any portion of his income is derived from the collection and/or the hauling of solid waste. (Per Arkansas Code Annotated § 8-6-721 "Licensing Haulers of Solid Waste."

Further: A.C.A. § 8-6-606 allows: for all solid waste generated and transported within the state but to be disposed of outside the state, there is imposed on each such solid waste transporter a solid waste transportation fee. The solid waste transporter fee on a weight basis shall be one dollar and fifty cents (\$1.50) for each ton of solid waste transported in the state.

## Fee Schedule:

**Annual Permit Fee:** \$100 to register two vehicles \$50 to register each vehicle over two

**Dual Registration:** Haulers who are headquartered in another District or Solid Waste Authority must either:

- 1. Show proof of registration and payment of all fees; or
- 2. Pay \$20 per vehicle for permits and registrations, unless a Reciprocal Agreement exists between the Districts and/or the Solid Waste Authorities

**Insurance Requirements:** Act 752 of 1991 requires all solid waste haulers to demonstrate proof of financial responsibility by annually providing proof of contractor/vehicle liability insurance with a minimum of \$65,000 coverage as required by state law. Include with this application a Certificate of Insurance provided by your insurance company that shows the coverage amounts and names the District as an additional insured on the proof of insurance.

**Acceptance:** I, the undersigned, have read and understand the Solid Waste Hauler Licensing Program of the Ozark Mountain Solid Waste District, and the rules and regulations pertaining to the collection and transportation of Solid Waste contained in the Arkansas Solid Waste Management Code of 1984 as Amended, Chapter4, Section XX, Collection and Transportation of Solid Waste, and I do hereby agree to abide by all applicable Federal, State, and Local laws and regulations.
